#### DESCRIPTION

Sikaflex<sup>®</sup>-212 FC is a 1-component sealant of paste-like consistency that cures on exposure to atmospheric humidity. It is designed for internal sealing applications.

AREAS OF APPLICATION


Sikaflex®-212 FC is a universal sealant which is suitable for most internal sealing applications in industrial commercial vehicle building. The product possesses excellent sealing properties and bonds well to most materials commonly used in the commercial vehicle industry, e.g. metals, plastics, wood and glass. Sikaflex®-212 FC bonds to itself, can be sanded and overpainted in its fully cured state.

Seek manufacturer's advice and perform tests on original substrates before using Sikaflex®-212 FC on materials prone to stress cracking. This product is suitable for experienced professional users only. Test with actual substrates and conditions have to be performed to ensure adhesion and material compatibility.

#### CURE MECHANISM

Sikaflex<sup>®</sup>-212 FC cures by reaction with atmospheric moisture. At low temperatures the water content of the air is generally lower and the curing reaction proceeds somewhat slower (see diagram 1).

### CHEMICAL RESISTANCE

Sikaflex®-212 FC is generally resistant to fresh water, seawater, diluted acids and diluted caustic solutions; temporarily resistant to fuels, mineral oils, vegetable and animal fats and oils; not resistant to organic acids, glycolic alcohol, concentrated mineral acids and caustic solutions or solvents.

### METHOD OF APPLICATION

#### **Surface Preparation**

Surfaces must be clean, dry and free from grease, oil and dust.

Surface treatment depends on the specific nature of the substrates and is crucial for a long lasting bond. Suggestions for surface preparation may be found on the current edition of the appropriate Sika<sup>®</sup> Pre-Treatment Chart. Consider that these suggestions are based on experience and have in any case to be verified by tests on original substrates.

### Application

Sikaflex<sup>®</sup>-212 FC can be processed between 5 °C and 35 °C but changes in reactivity and application properties have to be considered. The optimum temperature for substrate and sealant is between 15 °C and 25 °C.

Sikaflex®-212 FC can be processed with hand, pneumatic or electric driven piston guns as well as pump equipment. For advice on selecting and setting up a suitable pump system, contact the System Engineering Department of Sika Industry.

#### Tooling and finishing

Tooling and finishing must be carried out within the skin time of the sealant. It is recommended using Sika<sup>®</sup> Tooling Agent N. Other finishing agents must be tested for suitability and compatibility prior the use.

### Removal

Uncured Sikaflex<sup>®</sup>-212 FC can be removed from tools and equipment with Sika<sup>®</sup> Remover-208 or another suitable solvent. Once cured, the material can only be removed mechanically. Hands and exposed skin have to be washed immediately using hand wipes such as Sika<sup>®</sup> Cleaner-350H or a suitable industrial hand cleaner and water. Do not use solvents on skin!
